SERVICE DOG FEE WAIVER AFFIDAVIT
For the purpose of pet license fee waiver, a service dog is one that is specifically trained to do work or perform tasks for the benefit of an individual in the household with a disability. The task(s) performed by a service dog must be directly related to the handler's disability. The provision of emotional support, well-being, depression relief, protection, or companionship DO NOT constitute work or tasks for the purposes of this definition.
To qualify for the pet license fee waiver, you must truthfully answer the following questions and sign below.
Is the dog a service dog, and required due to a disability? What work or task has the dog been trained to perform?
I have read and understand the above definitions of 'disability' and of 'service dog'. I further understand that it is against the law to misrepresent my need for a service animal. The dog in question meets the requirements for fee waiver.
