- Accepting, sheltering and rehabilitating companion animals in need.
- Providing humane rescue, protection, prevention, adoption and education services.
- Implementing progressive life-saving and life-affirming programs.
- Collaborating and partnering with our region and supporters to build a model humane community.

#### **Executive Summary**

During 2012, Kitsap Humane Society (KHS) overcame major organizational and public relations challenges and rebuilt the organization while continuing to provide outstanding care for the animals.

### **<u>1. We advanced our progressive mission:</u>**



#### We admitted 4,703 animals into the shelter.

We rehomed 4,322 animals and maintained a 91.9% rehome rate by:

Adopting 3,415 animals

• Returning 677 animals, including 52% of all dogs, to their owners,

• Transferring 230 animals to other shelters/rescue organizations for adoption

We maintained a 94% lives saved/6% euthanasia rate.

We performed 3,751 spay/neuter surgeries – up 27% over 2011.

 67% more low-cost spay/neuter surgeries over 2011

# 2. We strengthened all the progressive programs that allow us to sustain the lives saved rate:

#### Volunteer/Foster care:

We rely heavily on volunteers who provide daily care, socialization and training for thousands of animals, increasing their adoptability.

- 2012 began with a decline in volunteer hours, but by spring, volunteer hours were on the upswing.
- Foster caregivers contributed 5,739 foster hours in December alone for at-risk and very young animals.



**Behavior:** We doubled the number of dogs assessed to provide adopters with better information about their prospective pet.

Outreach: 729 adoptions in outreach locations surpassed the goal of 600.

**Animal Control:** 1,970 cases were reported by county residents and investigated in 2012 via KHS' Animal Control personnel.

## 3. We strengthened the organization during a year of change:



• We rebuilt the Board of Directors and management of KHS.

We strengthened the Board-staff partnership

• We initiated a self-imposed investigative audit and publicly reported findings/recommendations

• We revamped many internal procedures; improved internal controls and oversight

• We restored public confidence in KHS and raised 31% more funds over 2011.

• We addressed severe budget shortfalls and moved KHS toward sustainability.
