REHABILITATION REFERS TO MEDICAL AND BEHAVIORAL REHABILITATION, REHOME REFERS TO REUNITED STRAY ANIMALS WITH THEIR OWNERS, ADOPTING OUT ANIMALS LEFT AT THE SHELTER OR SENDING ANIMALS OUT TO OTHER RESCUE ORGANIZATIONS. IN 2017, KHS RECEIVED 7,035 STRAY, ABANDONED AND SURRENDERED PETS, AND FOUND HOMES FOR 6,810 OF THOSE PETS. THE VETERINARY SERVICES ALSO PERFORMED SPAY/NEUTER SURGERY ON 5,607 ANIMALS.
